AIR CARRIER GROUPINGS

This Accounting and Reporting Directive updates the reporting groups for filing the Form 41 report during calendar year 2024 and replaces Reporting Directive No. 337. From our review, the reporting carrier groupings for the carriers below are updated as indicated:

AIR CARRIER: NEW REPORTING GROUP:

Sun Country Group II to Group III

JAFS Group I - \$20 million to \$100 million to Group II
Silver Airways Group I - \$20 million to \$100 million to Group II
Global Crossing Group I - \$20 million to \$100 million to Group II
Breeze Group I - \$20 million to \$100 million to Group II
Avelo Group I - \$20 million to \$100 million to Group II

Jet Edge Group II to Group I – under \$20 million

Carriers are grouped according to the operating revenue boundaries contained in Section 04 of Part 241. The current reporting levels are:

Group III Over \$1 billion;

Group II Over \$100 million to \$1 billion;

Group I \$100 million and under,

Subgroups:

Group I - \$20 million to \$100 million,

Group I - Under \$20 million.
